Summary of the Bilateral Treaty Network

As at January 11, 2013 Barbados has:

Double Taxation Agreements (DTAs)

In Force

- Thirty-two (32) DTAs in force. The CARICOM multilateral DTA counted as ten (10).
 - The new (revised) Barbados/U.K DTA entered into force on December 19, 2012.
 - The Protocol to the DTA with Sweden entered into force on December 12, 2012.

Awaiting ratification

• Five (5) signed DTAs with Ghana, Portugal, Bahrain, Qatar and San Marino that are awaiting ratification; and

Awaiting signature

• Five (5) initialed DTAs with Italy, Vietnam, Belgium, Singapore and Slovak Republic that are awaiting signature; and

Protocols To Existing Treaties Awaiting Ratification

• Three (3) signed Protocols to the existing DTAs with Finland, Norway and Canada.

Tax Information Exchange Agreements (TIEAs)

In Force

• One (1) TIEA in force with Denmark.

Awaiting ratification

• Two (2) signed TIEAs with Greenland and the Faroe Islands that are awaiting ratification.

Awaiting signature

• Three (3) initialed TIEAs with Germany, France and South Africa that are awaiting signature.

Bilateral Investment Treaties (BITs)

• Eleven (11) BITs signed with nine (9) currently in force. The two (2) BITs not in force are with Ghana and the Belgium Luxembourg Economic Union (BLEU). They are awaiting ratification.
